Registration

Registration will be done at the pool by filling out a registration form. Registration forms will be available at the pool office starting May 29. Payment can be made with check only (**no cash or credit cards**), and must be attached to the registration form at the time of registration. You must complete the: (1) registration form, and (2) waiver in order to participate in lessons. Payment is for the entire session. Lesson costs cannot be pro-rated for missed lessons. **Checks should be made payable to: Pool Guards, Inc.**

Evaluation

Evaluation for all participants will be held at the beginning of the first day of each session to determine the group level of each child. Groups having less than three (3) students will be cancelled.

Parent Information

We ask that parents watch lessons from the patio area, NOT on the pool deck. This helps children better focus on the lesson and instructor. Children who are not potty-trained must wear a swim diaper (+diaper cover) under their swimsuit. Email will be used as the primary method of contact for scheduling matters (such as weather cancellations).

Refunds

Refunds will not be issued more than 2 weeks after a session is over. Partial refunds will not be issued for any reason. Refunds only issued for cancellation of entire session. If you have any questions, please see the Lesson Coordinator or Pool Manager.

Pool Guards, Inc. Outdoor Lesson Waiver & Assumption of Risk

Important Information

Pool Guards, Inc. ("PGI") is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. PGI continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participant's safety. However, participants and parents/guardians of minors registering for swimming lessons must recognize that there is an inherent risk of injury when choosing to participate in such recreational activities/programs.

You are solely responsible for determining if you or your minor child/ward are physically fit and/or skilled for the activities contemplated by this activity. It is always advisable, especially if the participant is pregnant, disabled in any way, or has recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

Warning of Risk

Recreational activities/programs are intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning, and equipment, there is still a risk of serious injury when participating in any recreational activity/program. Understandably, not all hazards and dangers can be foreseen. As such, participants must understand that certain risks, dangers, and injuries due to slipping, falling, poor skill level or conditioning, carelessness, horseplay, unsportsmanlike conduct, premises defects, inadequate or defective equipment, and all other circumstances, inherent to swimming activities still exist. As such, it must be recognized that it is impossible for the PGI to guarantee absolute safety.

Waiver and Release of All Claims

Please read this document carefully and be aware that in signing it and participating in swimming lessons, you will be expressly assuming the risk and legal liability, and waiving and releasing PGI, its owners, officers, agents, volunteers, and employees from all claims for injuries, damages, or loss which you or your minor child/ward may sustain as a result of participating in any and all activities connected with and associated with the swimming instructions contemplated by this waiver and assumption of risk.

The undersigned recognizes and acknowledges that there are certain risks of physical injury to participants in these programs/activities, and voluntarily agrees to assume the full risk of any and all injuries, damages or loss, regardless of severity that the undersigned or their child/ward may sustain as a result of their participation. The undersigned further agrees to waive and relinquish all claims they or their minor child/ward may have (or subsequently accrue) as a result of participating in these programs/activities against PGI, and each of its owners, officers, agents, volunteers, and employees.

The undersigned does hereby fully release and forever discharge PGI, and each of its owners, officers, agents, volunteers, and employees from any and all claims for injuries, damages, or loss that the undersigned or their minor child/ward may have (or subsequently accrue) arising out of, connected with, or in any way associated with these programs/activities. This release shall be binding upon their undersigned and their minor child(ren)/ward(s), heirs, legal representatives, and assigns.

The undersigned has read and fully understands the above important information, warning of risk, and waiver and release of all claims.

PARTICIPATION WILL BE DENIED if the dated signature of an adult participant or parent/guardian of minor participant(s) are not on this waiver & assumption of risk.
